

Statement of Brook Hiddink: Legal Education

I, **Brook Hiddink**, founder of High Ticket (BERH Stores & Consulting Inc. - FZCO), make this statement to substantiate a claim used in High Ticket's advertising: my legal education. The exhibits below are unaltered copies of the records described, with third-party staff names blacked out.

1. I attended law school in Canada for two and a half years: my first year at **Queen's University** (Kingston, Ontario) and my second and third years at **Western University** (London, Ontario). For 2020-2021, Western Law named me to the **Dean's Honor List** (Exhibit A).
2. After my first year I was hired through the 1L student recruit as a summer law student at **McCarthy Tétrault** (Calgary, May to September 2020), working primarily on corporate law files (Exhibit B).
3. After my second year I was hired through the 2L student recruit as a summer law student at **Davies Ward Phillips & Vineberg LLP** (Toronto, May to August 2021), where I worked on legal files. The firm extended me an early written offer of an articling position, announced in the email to its Toronto summer students reproduced as Exhibit C.
4. I withdrew from law school during my third and final year, because of the success of my e-commerce ventures, and did not complete articling. I did not obtain a law degree and have never been licensed to practise law.
5. Supported wording: "**former law student**", "**Dean's List law student who worked at two of Canada's top law firms and turned down an articling position at Davies Ward Phillips & Vineberg to build his business**".

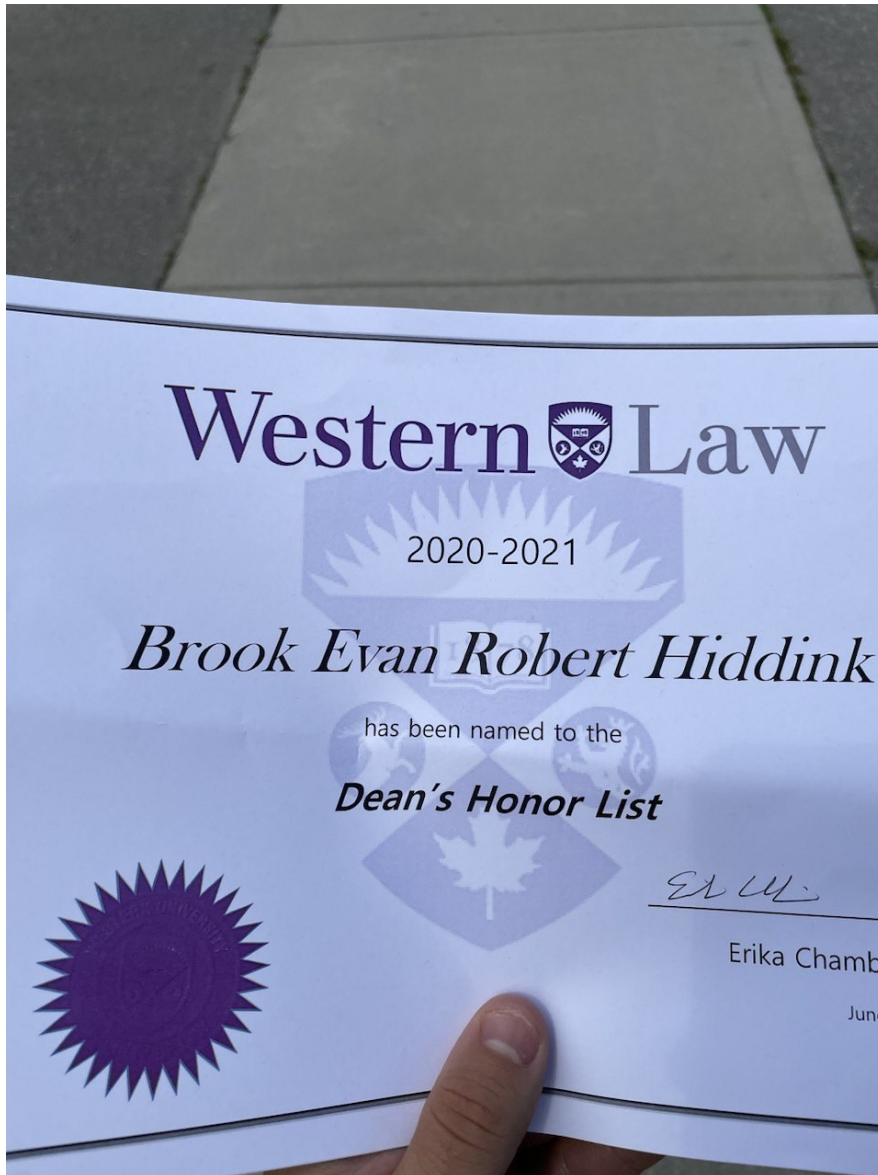
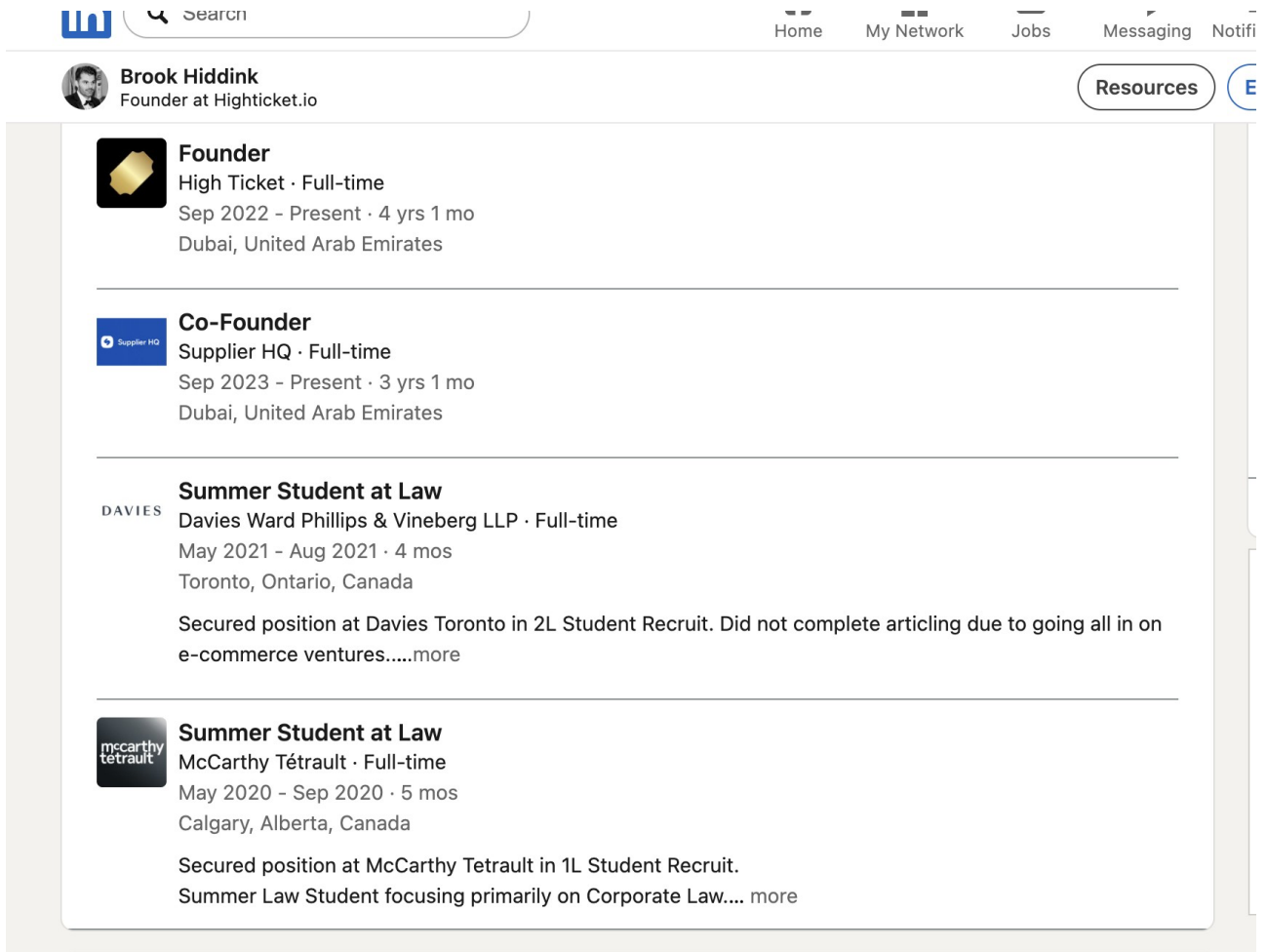

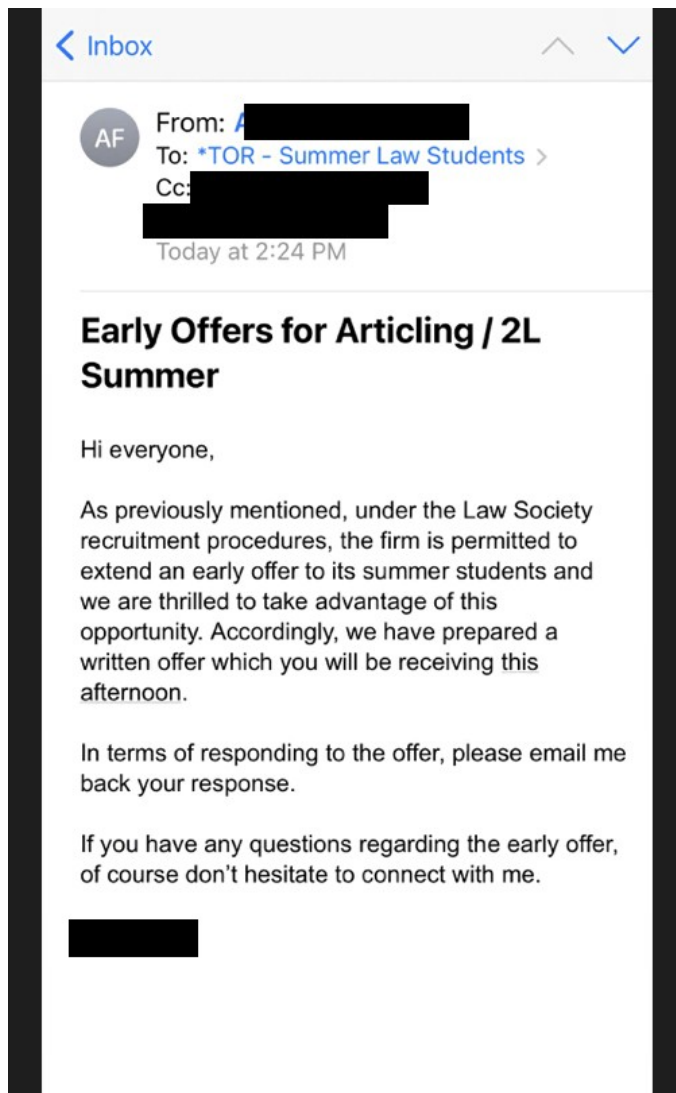
