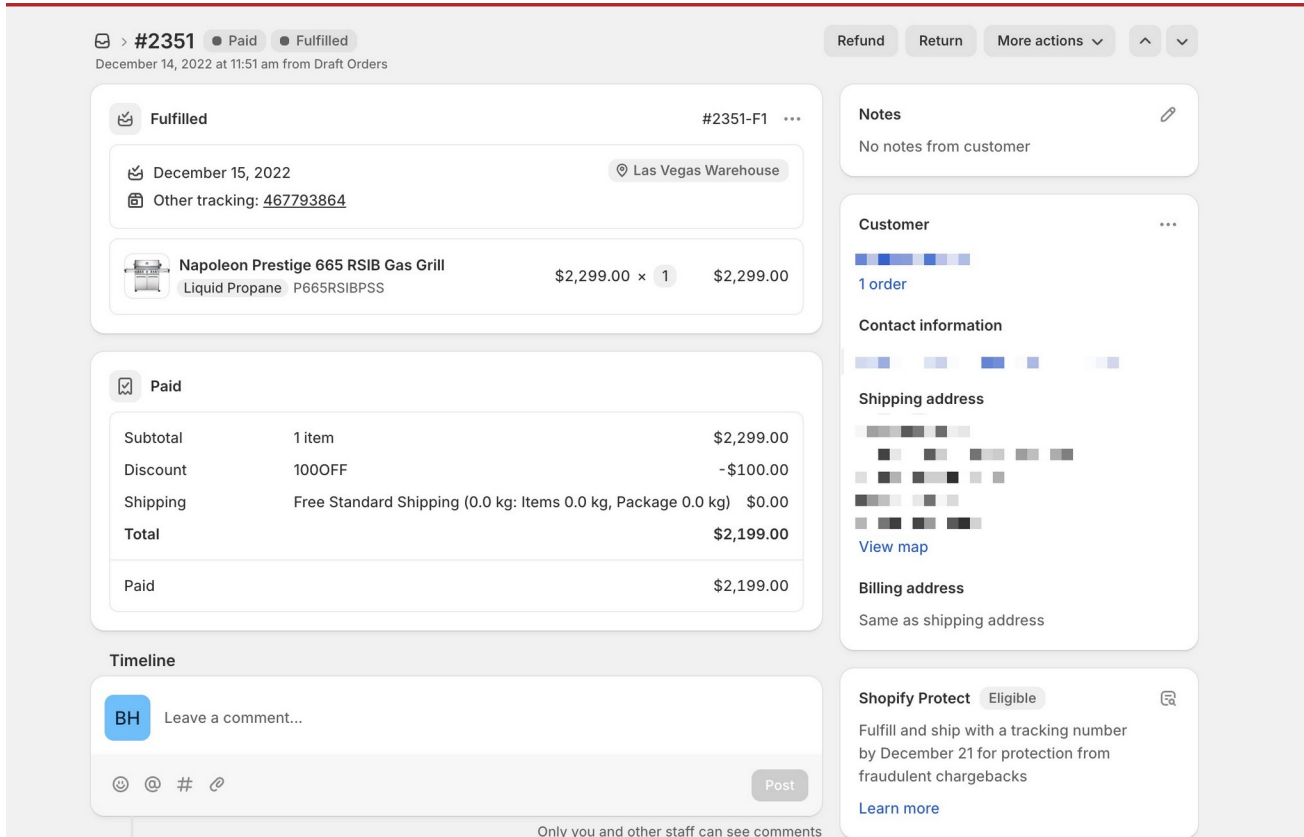


Statement of Brook Hiddink: A Brand My Store Sold That Home Depot Also Stocks

I, **Brook Hiddink**, founder of High Ticket (BERH Stores & Consulting Inc. - FZCO), make this statement to document a claim used in High Ticket's advertising: "I partner with the same product makers Home Depot stocks". The exhibits below are unaltered copies of the records described.

1. On **December 14, 2022**, my store sold a **Napoleon Prestige 665 RSIB gas grill** under Shopify order **#2351**, listed at \$2,299.00 and sold with a \$100.00 discount for **\$2,199.00**, paid in full and fulfilled the next day (Exhibit A; customer details blurred).
2. Napoleon products are sold by The Home Depot. As of September 22, 2026, Home Depot lists Napoleon products online, for example the Napoleon Timberwolf 18 in. smokeless fire pit at homedepot.com (Exhibit B, link 1).
3. Napoleon runs a public dealer program. Its "Become a Dealer" page at napoleon.com invites applications and lists "eCommerce" among the divisions a dealer can apply to sell (Exhibit B, link 2). My store's Napoleon dealer account is the basis on which it bought the grill at dealer pricing.
4. Supported wording: "brands that Home Depot stocks also work with independent online dealers, and my store sold one of them". This is a historical example from a store I no longer operate.
